### THE TOPIC IS SECURITY. LET'S BEGIN BY PUTTING THE TOPIC INTO PERSPECTIVE.

FLORIDA HAS 267 CITIES, 123 TOWNS AND 21 VILLAGES FOR A TOTAL OF 411 INCORPORATED FLORIDA MUNICIPALITIES - DISTRIBUTED ACROSS 67 COUNTIES.

Out of the 267 Florida cities, SafeWise ranks Safety Harbor as the 15th safest, with a violent crime rate of 1.07 incidents for every 1,000 people and a property crime rate of 14.04 incidents for every 1,000 people.

OVER THE YEARS, LOS PRADOS HAS EXPERIENCED SOME 'CRIMES OF OPPORTUNITY' SUCH AS:

- 1. PERSONS SEEKING ENTRY TO UNLOCKED-VEHICLES BY TRYING RANDOM DOORHANDLES,
- 2. THE OCCASIONAL DRUG-DEAL DUE TO OUR "MEETUP" GEOGRAPHICAL LOCATION AND
- 3. A JOYRIDE-SEEKING TEENAGER STEALING A VEHICLE (AND APPREHENDED).



## (C) UNIT'S ENTRANCE LIGHTS

### AN OWNER'S FRONT ENTRANCE EXTERIOR LED LIGHT WOULD HAVE 2 SENSORS:

- 1. DAYLIGHT/NIGHTTIME SENSOR.
- 2. MOTION-DETECTOR SENSOR.

# A NEW INTERIOR FRONT DOOR SWITCH WOULD CONTROL THE UNIT'S EXTERIOR LIGHT WITH 1 OF 4 SETTINGS:

- SETTING-1: LIGHT IS SELECTED TO OFF (OVERRIDES SENSORS & BEHAVES AS A NORMAL LIGHT SWITCH).
- SETTING-2: LIGHT IS SELECTED TO ON (OVERRIDES SENSORS & BEHAVES AS A NORMAL LIGHT SWITCH).
- SETTING-3: LIGHT IS PERMANENTLY ON WHEN DARKNESS FALLS, BUT OFF UPON  $\mathbf{1}^{ST}$  LIGHT.
- SETTING-4: LIGHT TURNS ON WITH MOTION DURING DARKNESS BUT:
  - A. PERMANENTLY TURNS OFF UPON 1<sup>ST</sup> LIGHT AND
  - B. TEMPORARILY TURNS OFF IF THERE'S NO MOTION DURING DARKNESS.

### (D) CARPORT LIGHTS AND VEHICLE PROXIMITY ALARM

THIS WOULD BE EXACTLY THE SAME AS "(C)" ABOVE FOR CONDO UNITS EXCEPT SOLAR-DRIVEN BECAUSE NO CARPORT-WIRING IS READILY-AVAILABLE AND WOULD BE TOO EXPENSIVE TO INSTALL.

### A CARPORT'S EXTERIOR LED LIGHT WOULD HAVE 2 SENSORS:

- 1. DAYLIGHT/NIGHTTIME SENSOR.
- MOTION-DETECTOR SENSOR.

### A SWITCH WOULD CONTROL THE CARPORT'S LIGHT WITH 1 OF 4 SETTINGS:

- SETTING-1: LIGHT IS SELECTED TO OFF (OVERRIDES SENSORS & BEHAVES AS A NORMAL LIGHT SWITCH).
- SETTING-2: LIGHT IS SELECTED TO ON (OVERRIDES SENSORS & BEHAVES AS A NORMAL LIGHT SWITCH).
- SETTING-3: LIGHT IS PERMANENTLY ON WHEN DARKNESS FALLS, BUT OFF UPON 1<sup>ST</sup> LIGHT.
- SETTING-4: LIGHT TURNS ON WITH MOTION DURING DARKNESS BUT:
  - **A.** PERMANENTLY TURNS OFF UPON  $\mathbf{1}^{\mathsf{ST}}$  LIGHT AND
  - B. TEMPORARILY TURNS OFF IF THERE'S NO MOTION DURING DARKNESS.

### AT AN OWNER'S OPTIONAL EXPENSE ... WITHIN THEIR INDIVIDUAL CARPORT SPACE:

A MOTION-ACTIVATED, SOLAR-POWERED RINGTONE DEVICE WOULD BE INSTALLED TO:

- **1.** Take a photo of someone approaching the vehicle.
- 2. TRIGGER A LOW-AUDIBLE "VEHICLE PROXIMITY ALARM" UTILIZING SETTING-4 ABOVE.

### (E) RINGTONE DOORBELL

WE USE THE TERM "RINGTONE" TO APPLY TO ANY FRONT DOOR MOTION-DETECTING SYSTEM, WHEREBY WHEN SOMEONE MOVES PAST THE FRONT DOOR, A PHOTO IS TAKEN OR A VIDEO IS INITIATED AND SENT TO THE OCCUPANT AS AN EMAIL ALERT.

FOR PRIVACY REASONS, THE PROPERTY-WIDE CAMERA SYSTEMS THAT HAVE BEEN INVESTIGATED PURPOSELY <u>DO NOT</u> INCLUDE THE UPLOADING OF "RINGTONE" DATA TO THEIR CLOUD-BASED CAMERA DATABASE ... THERE ARE SOME RESIDENTS WHO DON'T WISH ANYONE TO KNOW WHO MAY BE VISITING THEIR CONDO.

THE BOARD ENVISIONS THAT EVERY UNIT WILL HAVE A RINGTONE DOORBELL, BECAUSE ITS MERE EXISTENCE REPRESENTS A STRONG DETERRENT. SINCE ITS DATA WOULD **NOT** BE UPLOADED TO A CAMERA SYSTEM'S CLOUD, ITS BASIC "ALERT PHOTO/VIDEO" BEING EMAILED TO THE OCCUPANT WOULD SERVE AS AN EVENT'S TIME-STAMP.

# FOR EXAMPLE, LET'S TAKE THE CASE OF AN EVILDOER STEALING AN AMAZON DELIVERED PACKAGE FROM A FRONT DOOR:

- 1. THE "ALERT PHOTO/VIDEO" IS TAKEN BY RINGTONE TO ESTABLISH THE DATE AND TIME-OF-DAY (TIME-STAMP) AND SENT TO THE OCCUPANT.
- 2. THAT TIME-STAMPED PHOTO/VIDEO IS PROVIDED TO LAW ENFORCEMENT.
- 3. WITH THE TIME-STAMP IN HAND, LAW ENFORCEMENT CAB SEARCH THE CAMERA DATABASE, WHICH COULD VERY WELL DETECT AN EXITING VEHICLE DURING THAT TIME-FRAME.

### IN SUMMATION, RINGTONE PROVIDES 4 STRONG SECURITY FEATURES:

- 1. ITS MERE EXISTENCE ACTS AS A DETERRENT.
- 2. ALERTS AN OCCUPANT TO A DOORBELL RING, WHEREBY THE OCCUPANT CAN VIEW FRONT-DOOR ACTIVITY.
- 3. EMAILS AN ALERT PHOTO/VIDEO TO THE OCCUPANT, THEREBY ESTABLISHING A TIMESTAMP.
- **4.** The timestamp may be used by Law Enforcement if there was an associated crime.

### (F) BACK GATE

THE REAR ENTRANCE (OR BACK GATE) BACK GATE PRESENTS ITS OWN CHALLENGES.

- 1. LARGE DELIVERY AND CONTRACTOR TRUCKS, AS WELL AS MOVING VANS THAT NEARLY-DAILY FREQUENT OUR PROPERTY (ALL OF WHICH ARE WITHOUT REMOTES) PRESENT A CLEAR AND PRESENT DANGER IN TERMS OF THEIR NECESSITY TO "BACK-UP" FOR A LONG DISTANCE TO ACCESS THE FRONT ENTRANCE. DANGER TO PEDESTRIANS, VEHICLES AND CARPORT INFRASTRUCTURE.
- 2. Non-residents coming onto the Property from surrounding areas for dog-walking and/or cut-through reasons.

### **SOLUTION**


- Install a Camera System for the Back Gate identical to that of the Front Gate.
- 2. WIRE THE BACK GATE TO OPEN WITHOUT A REMOTE WHEN A VEHICLE IS EXITING, WITH THE REMOTE ONLY REQUIRED UPON ENTERING THE PROPERTY. SUCH WOULD SOLVE THE 'EXITING OF LARGE-VEHICLES' PROBLEM. CURRENTLY, IT IS EXCEEDINGLY DANGEROUS FOR PEDESTRIANS AS WELL VEHICLE AND CARPORTS TO HAVE SUCH LARGE VEHICLES TRYING TO EXIT AFTER DELIVERIES TO UNITS

If the Gate becomes mechanically inoperable, it's not fatal, because the Front Entrance is always available and vehicles stacked up on Oak Street do not pose the same danger-level as being stacked-up on MLK/McMullen Booth Road.

AT FIRST BLUSH, HAVING A FRONT GATE SOUNDS LIKE IT WOULD BE A NECESSARY COMPONENT OF A VIABLE 'PROPOSED SECURITY SYSTEM', BUT THAT BELIEF IS WRONG.

THE NOW-DECEASED RONALD LOONEY AND A THEN BOARD MEMBER APPROXIMATELY 4-YEARS AGO DID AN EXHAUSTIVE INVESTIGATION REGARDING THE EFFICACY OF INSTALLING A FRONT GATE. AS A RESULT OF HIS WORK, WE LEARNED THE FOLLOWING:

- 1. BECAUSE OF OUR LOCATION, SAFETY HARBOR ZONING DOES NOT ALLOW SUCH A GATE TO BE LOCATED AT THE EXACT ENTRANCE LOCATION WHERE YOU MIGHT THINK IT WOULD LOGICALLY BE STATIONED. THEIR LOGIC IS SOUND.
  - A. THE OBJECTIVE OF A FRONT GATE IS OBVIOUSLY TO INTRODUCE A POLICY OF RESTRICTION.
  - **B.** IN SUCH A RESTRICTIVE VENUE, A **60**-FOOT TURN-AROUND DISTANCE "INSIDE THE PROPERTY": IS THE REQUIRED 'TURN-AROUND DISTANCE' FOR THOSE VEHICLES NOT SATISFYING ANY IMPOSED RESTRICTIONS.
  - c. Moreover, to prevent walkers from "Going-Around" the Gate, there would have to be horizontal fencing in front of Building's 1 & 2 an unfair visual nightmare for the Owners in that location.
  - D. AS STATED BY SAFETY HARBOR ZONING, JUST 1 OR 2 STATIONARY VEHICLES WAITING TO GAIN ENTRY WITH NEW VALID VEHICLES STACKED-UP BEHIND THEM WOULD BE SUFFICIENT TO CREATE A DANGEROUS BACK-UP SCENARIO ONTO MLK AND THEN POTENTIALLY ONTO MCMULLEN BOOTH ROAD.
  - E. AND THE ABOVE ALL ASSUMES A "WORKING GATE" ... WHAT HAPPENS WHEN IT'S NOT WORKING (AS SOMETIMES OCCURS WITH SUCH MECHANICAL DEVICES).
- 2. WE ARE STILL TRYING TO LOCATE THE ACTUAL QUOTE, BUT IT'S CLEARLY REMEMBERED TO BE IN THE RANGE OF \$60,000.
- 3. LASTLY, WHO'S GOING TO ADMINISTER SUCH A SYSTEM WHICH WOULD NO DOUBT REQUIRE VEHICLES TO BE VERIFIED BEFORE ENTERING? SUCH A PROGRAM WORKS BEST FOR PROPERTIES WHO HAVE A MANNED GUARD HOUSE, BUT THAT'S BEYOND OUR AFFORDABILITY LEVEL.
